Notes

The above fees exclude GST. Please note that GST is not charged if the contract/agreement to provide services is with the client/individual receiving the services, otherwise GST will be charged.

Minimum shift charges may apply, as well as minimum hours of support for certain services which will be specified in your schedule of supports.

Prices are generally calculated on an hourly rate, with the exception of Short-Term Accommodation which is a minimum 24 hour charge and establishment fees which are a one-off payment.

Price varies based on time of day and day of week.

- Weekday is defined as Monday Friday 6:00am 8:00pm.
- Weekday Afternoon and Evening is defined as Monday Friday 8:00pm 12:00am.
- Weekday Night is defined as Monday Friday commencing at or before midnight and finishing after midnight, or support commencing before 6:00am. An exception to this general rule occurs when a particular support crosses a shift boundary and the same worker delivers the entire support.
- In this case, the higher of the relevant price limits applies to the entire support.
- Saturdays, Sundays and Public Holidays there is only one hourly rate for services from 6.00am- 12.00am.
- Night- time Sleepover Support is any support delivered on weekdays, Saturdays, Sundays or Public Holidays that commences before midnight and finishes after midnight the next day, is for a continuous period of eight hours or more, and the worker is allowed to sleep when they are not providing support. This support includes up to two hours of active supports for the duration of the period. Centacare will claim for a third or additional active hours at Saturday rates on weekdays, or at applicable rates on Saturday, Sunday or Public Holidays.

A cancellation fee may apply if you cancel a service with less than 2 business days' notice for services booked up to \$1000 and 5 business days' notice for services booked over \$1000.

Where applicable, prices include the Temporary Transformation Payment (TTP). This payment is designed to assist providers who meet specific criteria, to transform their business operations to respond to the needs of clients and help them achieve their goals in line with the new NDIS framework. Centacare is a registered NDIS Provider and meets the requirements to charge the TTP rate.

Intensity of support is based on the support needs of the client with respect to the skills and experience required by a support worker or other staff member to deliver the support. For example, this may include managing challenging behaviours or providing complex medical support. There are different price limits depending on the level of intensity.
